These release notes provide information about the DataMotion Direct Release 6.1, including a summary of new features, issues resolved, and known limitations. This is a major release which includes updates to the HPD Search Window and the highly anticipated HPD Search API.

NEW FEATURES IN THIS RELEASE

The following features are introduced in this release:

HPD SEARCH API

The HPD API is now available to use for all companies who have their own user interfaces and do not wish to use the DataMotion web portal. The HPD API is available via the DataMotion Direct Software Development Kit which contains all of the required information necessary for developers to begin working with this API.

IMPROVED FEATURES IN THIS RELEASE

HPD SEARCH WINDOW UPDATES

This release implements a greatly improved Health Provider Directory (HPD) Search Window. The HPD Search Window now displays all of the search fields and options in two accordion sections. When you click the Access HPD... button from the address book, it opens the HPD Search Window and displays the Search Filters section.

Note: Clicking the label of the section you are not currently viewing will collapse the one that is open and expand the one that you click.

This Search Filters section contains fields that can be used to search the provider directory and receive results. The Specialties field and the NPI field are now a part of both the Provider and Organization filters. New fields have also been added, including the Role field in the Provider section, and the Phone, Fax, and NPI in the Organization section. When searching for an NPI in either the Provider or Organization sections, it is possible to prefill the NPI field with data as long as the number you are searching for matches an existing NPI record. To aid users looking for a particular type of medical provider, the Specialty field now has an auto complete functionality that shows a drop-down of specialties based on text typed into the field. For example, if you type the word “Cardio,” you will see a drop-down containing specialties with that word. To further assist users in searching for provider information, a wildcard character has been included in this update. The wildcard character allows you to type a part of a search such as “%City” which will display all results containing text before the word City.

Clicking the Search button will collapse the Search Filters section, and expand the Search Results section. Most of the functionality within the Search Results remains the same. . When you click a “...” button next to a provider listing in the Search Results section, it opens a Provider Details window containing additional information about the Provider. This allows you to view a provider’s details and still use all of the features provided by the Search Window at the same time.

MAJOR UPDATE TO ONLINE HELP

The online help has undergone a major update. The content has been fully updated and improved to provide better clarification of the features available to users on the web portal.

TERMS OF SERVICE AND BUSINESS ASSOCIATE AGREEMENT

Links to the Terms of Service and the Business Associate Agreement (BAA) have been added to all web pages in the web portal. They can be found on the bottom right hand side of the screen to the left of the Copyright link.

MESSAGE DISPOSITION NOTIFICATION FUNCTIONALITY

The behavior of MDNs has been changed to always send a “failed” MDN whenever the delivery of a message fails, and to send a “dispatched” (indicating successful delivery) MDN only if the Health Information Service Provider (HISP) requests it.

TOTAL VIEW REPORT

The Total View Report available to Admin users has been updated to include messages from external domains. When a Total View Report is generated, the To and From columns will now show every message that has been sent and received.

RESOLVED ISSUES

The following-reported issues have been resolved in this release.

Table 1. Resolved Issues v6.1

Original Issue	Description
Long text in the HPD Search Window would not wrap.	If a field in the HPD contained text that was too long it would not wrap appropriately. This has been fixed.
Could not save a draft message after adding recipients to message from address book.	If the Address Book was accessed from the Member Center and a user was added to either the To, Cc, or Bcc field, then the message would not be saved as a draft. This has been fixed.
Unable to access Group Mailbox Access Report in certain cases.	Whenever an attempt was made to generate the Group Mailbox Access Report and no dates were put in, an error page was displayed. This has been corrected and the error page will no longer appear.
Embedded images in the message body do not display when viewing the message.	Whenever a message was sent with an image pasted into the text body, it would not appear when opened on the portal. Images will now appear in the text body as expected.
Users with ampersands in their Direct addresses could not access the create a password screen.	Previously Direct addresses containing ampersands in the user name were not recognized as proper Direct addresses. This has been fixed.
Searching only a Specialty in the HPD Search Window would return zero results.	Whenever a search would be performed on the HPD and only the Specialty field was used, no results would be found. This has been fixed.
Validation on Direct addresses which were malformed.	If a Direct address contained a semicolon in the user name, it would time out and fail to validate. A check was also put in to eliminate any issues with a semicolon appearing either before or after the domain.

Description/Resolution
Mobile functionality is not available for Windows 8 Phones.
Inserting hyperlinks into the message body on the Compose screen only works with Internet Explorer 11.
