NEW FEATURES IN THIS RELEASE

The following features are introduced in this release:

GROUP MAILBOXES

This release adds a Group Address Mailbox as part of the DataMotion Direct Secure Messaging Portal. The group mailbox configuration provides the ability to delegate other Direct accounts (which must be within the same company) to access and respond to messages on behalf of the account owner. This allows users who are delegates to read, respond to, and download messages for the owner. Delegates can also view and download attachments. The delegates are not granted permission to access the contacts in the address book of the user they are delegated under, delete messages, or send entirely new messages on behalf of that user. Delegates must have a Direct messaging address within the same company, and any messages they send for the user they are delegated under will be shown as being sent from their Direct address instead.

C-CDA VIEWER: PRINT BUTTON

This release adds a Print button to the C-CDA Viewer that was introduced in DataMotion Direct Release 5.35. While viewing the pop up window that is displayed after clicking the “view” link inside of a message, a

Print button will be displayed. When pressed, a print window pops up where the user can print the CCD information displayed in the viewer.

ADDRESS BOOK-HPD SEARCH

This release implements a completely revised Address Book, which now includes the ability to search a Health Provider Directory (HPD). This HPD search window allows Direct users to search through a directory that contains users with Direct Addresses, and add them to the address book and to messages. You can search the DataMotion Direct HPD database, and depending upon your organization, you may have access to one or more additional HPD databases, including the MiHIN HPD database.

RESOLVED ISSUES

The following-reported issues that have been resolved in this release.

Table 1. Resolved Issues v6.0

Original Issue	Description/Resolution
The Address Book did not prompt to save any uncommitted changes.	When attempting to leave the Address Book page after adding, deleting, or modifying a user within the fields, a popup box will now appear stating “This page is asking you to confirm that you want to leave - data you have entered may not be saved.”
Could not create direct messaging accounts with addresses that contain apostrophe’s or ampersands.	Apostrophe and ampersand special characters in direct addresses would fail due to encoding changing their resulting appearance, making it seem like the account did not exist. Encoding has now been removed before checking for existence fixing this problem.
Bulk import accounts were disabled.	This occurred even when the import accounts were set to be enabled. The bulk import is not a supported feature and is no longer displayed as an option as a result.
When you do a bulk import and leave the sso field blank it will always give error that sso id already exists.	Same as above, bulk import is no longer displayed.
With the Help tab opened, clicking any link to open a different help page would fail.	The Help button link “/help/” was being encoded which caused the links to send improperly. The encoding was removed and the links now work properly.
Notification Email had No Domain Validation.	Admins were able to change the notification email in the User Information section to a non-valid email and it would save with no errors. This has been corrected.



KNOWN ISSUES

The following are known issues in this release.

Table 2. Known Issues

Description/Resolution
Script upgrade on three tier installations is not supported.
Currently the MiHIN HPD “search within radius” for mileage is not supported. The mileage search radius shall be made fully functional at a later date.
Inserting hyperlinks into any browser except for Internet Explorer 11.
