NEW FEATURES IN THIS RELEASE

DKIM

When enabled by DataMotion Support (on-premise customers may enable this feature themselves) for a company this feature will allow company administrators to access a new management console within the Administrative Tools called DKIM Management. The DKIM Management console will display the company of the current administrator, and allow the administrator to set a Domain Name, a Selector, and a Canonicalization Algorithm. The number of domains permitted per company can be set from 1 to 1000 depending on the need of the company. It is also possible to allow sub-domain signing for 2 level domain certificates as well.

NOTE: The Administrator who is configuring the DKIM Management console should have a working understanding of how DKIM functions in order to properly configure these settings.

CHANGES AND ENHANCEMENTS MADE IN THIS RELEASE

SECURE MESSAGING API

The Secure Messaging API call GetMessageSummariesWithMetadata has been optimized in this release to return results with a quicker response time.

SECURITY STATUS TEXT UPDATE

The Security Status: label on the SecureMail web portal has been updated to display "Login is secured by an encrypted link (TLS) to our server." This change has been implemented as SSL has been deprecated and only TLS 1.2 will be supported moving forward.

TLS 1.2

Moving forward, all connections on DataMotion SecureMail will be TLS 1.2 only. TLS versions 1.0 and 1.1 have been deprecated and will no longer be allowed for the sake of security. All customers who have DataMotion Secure Mail deployed on premises or in a public cloud (AWS, Microsoft Azure, etc) can take advantage of this enhancement and disable TLS 1.0 and TLS 1.1 for their users.
